NOTES TO THE FUNDS STATEMENT

FIRST QUARTER

JUNE 1 - AUGUST 31, 2006

- GOL-(Government of Liberia)- During the first quarter, there were no additional commitment received as a result of delays in the passage of the fiscal year July 2006- June 2007 budget in which US\$1.438m was appropriated as administrative support for the TRC. Residual commitment from the preparatory phase was used to finance activities at the inception of the operational period.
- ❖ UNDP- (United Nation Development Programme) made an additional expenditure from the commitment in the amount of US\$171,129.25 (One Hundred and Seventy One Thousand One Hundred Twenty Nine ...25/100 Dollars) to the TRC process.
- EC-(European Union/Commission)- during this period provided logistical and capacity building support which amount to US\$14, 639.00 (Fourteen Thousand Six Hundred Thirty Nine United States Dollars).
- ❖ OSIWA-(Open Society Initiative for West Africa) during the period the TRC received initial contribution of US\$158, 290.00 (One Hundred Fifty Eight Thousand Two Hundred Ninety United States Dollars). The amount of US\$157,355.71 (One Hundred Fifty Seven Thousand Three Hundred Fifty Five...71/100 was expended on logistics and other programs.
